PUBLIC COMMENTS ON ANY AGENDA ITEM— Matthew Stefanak, chairman. No comments were made.

MINUTES OF January 28, 2025, MEETING-

A motion was made by Elliot Lengel and seconded by Stephen Theiss to approve the Minutes of the January 28, 2024 meeting. The Chairman called for any discussion; hearing none, a vote was called for; the **motion** carried.

FINANCIAL STATEMENTS - Nick Hanahan, committee treasurer.

Nick Hanahan presented the January 2025 Financial Statements.

A motion was made by Nick Hanahan and seconded by Paul Hamill to approve the financial statements as presented. The Chairman called for any discussion; hearing none, a vote was called for; the motion carried.

Special Presentation- Lawrence-Mercer Recycling & Solid Waste- Jerry Zona and Megan Gahring gave a presentation on current legislation and ongoing recycling projects.

ZONING AND SUBDIVISION Larry McAdams presented the committee report

- Zoning Ordinance Text Amendment Pine Township Amendments to add energy generation
 facility as a conditional use in the industrial zoning district, and energy generation system as an
 accessory use in all zoning districts. A motion was made by Larry McAdams and seconded by Rich
 McCullough to approve the plan with additional access to the road. The Chairman called for any
 discussion; hearing none, a vote was called for; the motion carried.
- 2. Zoning Ordinance Text Amendment Coolspring Township Proposed amendments revised by Township Supervisors to allow energy generation facilities as Conditional Use in the Agricultural, Residential-1, Industrial and Commercial districts. Energy generation facilities cannot use Battery storage. During the committee discussion, Coolspring Township Planning Commission presented the recommendations they had provided to the Township supervisors. Those permitted Energy Generation Facilities only in Commercial and Industrial districts, removed from Agriculture, R-1 and R-2.

Mr. Corey Mason, Coolspring Supervisor, discussed the amendment that had been submitted by the Coolspring Supervisors and Mr. Hans Jorgensen, from the Coolspring Planning board discussed their recommendations that differ from the supervisors.

It was clarified that the Mercer County Zoning and Subdivision Committee recommend the approval of the text amendment submitted by the Coolspring Planning Board. Solicitor Nevant recapped for the Board the PA MPC regulation. After discussion the motion was made by Larry McAdams and seconded by Paul Hamill to recommend that the Township accept the recommendations of the Coolspring Township Planning Commission letter dated January 31, 2025. The motion passed with 5 nay votes: Steve Tingley, Tom Sauer, Cory Masson, Elliot Lengel, and Paulette Young.

APRIL

POSTING & BONDING OF LOCAL ROADS

10

Many rural roads and urban streets were not built to carry today's heavy loads. This course reviews laws governing posting and bonding, requirements for developing and implementing a posting and bonding program, and ways to monitor a program. Participants will also examine a sample bonding agreement.

STOP SIGNS & INTERSECTION TRAFFIC CONTROL

APRIL 10

This course focuses on stop signs and other controls that improve safety at unsignalized intersections. This course will cover effective implementation of stop signs, components of stop sign placement, common intersection problems such as unwarranted stop signs and multi-way stop intersections, as well as suggestions for accomodating uncommon challenges. The course will also cover additional safety features used at intersections such as pavement markings and rumble strips.

PAVEMENT MARKINGS

APRIL 11

The consistent application and maintenance of pavement markings are paramount to motorists' safety. This course covers all aspects of pavement markings from their purpose and intent to their installation and maintenance on roadways. Content is based on the Federal Highway Administration's Manual on Uniform Traffic Control Devices (MUTCD) and the most current Pennsylvania Department of Transportation (PennDOT) practices, regulations and resources. Participants will discuss and learn more about materials, applications, installation, and maintenance of pavement markings.

UNPAVED & GRAVEL ROADS COMMON MAINTENANCE PRACTICES

APRIL 24

This course addresses basic maintenance techniques for unpaved and gravel roads. Topics include the importance of good drainage, surface aggregate and dust control materials, and operational techniques. These techniques include blading, reshaping, regraveling, and dust control. Driving Surface Aggregate (DSA) specifications and use are reviewed. Factors used to determine when to upgrade a gravel road by paving or seal coating the roadway are discussed. This class does not qualify a municipality to obtain dirt and gravel road funds, but rather teaches them how to better use such funds.

BRIDGE & CULVERT INSPECTION FOR MUNICIPALITIES

MAY 1

The Federal Highway Administration requires the inspection of structures over 20 feet long. This course discusses why the requirements for inspection were established and ownership responsibilities. Components and terminology required to read inspection reports of different bridges and culverts, including the approach roadway, deck, superstructure, and substructure are discussed. The course also discusses common and uncommon failure mechanisms typically encountered on smaller span structures.

DRAINAGE: THE KEY TO ROADS THAT LAST

MAY 6 This course covers the effect of water on roadways, emphasizing problems caused by poor drainage with discussion on various ways to handle these problems. Basic roadway drainage systems and their usage are reviewed, as are detailed industry standard procedures for replacing cross pipes. Regulatory agency policies and permit requirements are presented. The importance of performing routine inspection of drainage system assets is discussed with emphasis on the relationship to planning and Federal Aid reimbursement in the case of a disaster.

ROADSIDE VEGETATION CONTROL

MAY

8

JUNE

10

This course provides the knowledge and understanding needed to establish an efficient and effective roadside vegetation control program. It is based on the concept of an Integrated Vegetation Management philosophy that utilizes manual, mechanical, and chemical control methods to manage roadside vegetation. It also reviews laws and regulations regarding required applicator certification. This course has been approved by the Pa. Department of Agriculture for Continuing Education Unit credits for those who have received pesticide applicator certification.

ASPHALT ROADS: COMMON MAINTENANCE PROBLEMS

pavements. The course material reviews the importance of preventive maintenance to the life of an asphalt pavement as well as common asphalt distress, the cause of the distress, and the appropriate treatments. The latest techniques, materials, and equipment will be reviewed with an emphasis on repairing the asphalt distress properly the first time. Current industry standards to properly repair problems such as cracking and potholes will be presented, as well as the basics of treatments such as seal coats, micro surfacing, and overlays. A review of the latest treatments included in PennDOT Publication 447 Approved Products for Lower Volume Local Roads, will be covered.

PRINCIPLES OF PAVING

MAY 27

This course is for employees who are involved in the planning, inspecting, and placement of asphalt paving operations. The course will provide the information needed to properly plan and monitor an asphalt paving project. Basic knowledge of asphalt materials and construction specifications will be provided based on national and state guidelines. The importance of proper roadway preparation to obtain a long-lasting product will be discussed followed by a basic discussion of the delivery, placement, and compaction process in paving operations.
