The City of Farrell is requesting proposals from qualified engineering firms to provide professional design and construction administration services for a Community Development Block Grant (CDBG)-funded project involving:

- Construction of a public parking lot on Spearman Avenue
- Full-depth street reconstruction of Bond Street and Darr Avenue
- Along with other Federal Fiscal Year projects.

The selected firm must be familiar with CDBG project requirements, including Davis-Bacon compliance, Section 3, and HUD reporting.

- Limited stormwater improvements (as needed)

Professional Liability Insurance is required for this project. Please indicate the level of coverage provided. The proposer must certify that it is not debarred, suspended, or otherwise excluded from participation in federally assisted programs as defined in 2 CFR Part 180 and 2 CFR Part 2424. Proposers must provide a signed certification regarding compliance with the Byrd Anti-Lobbying Amendment. If applicable, disclosure of lobbying activities (SF-LLL) must also be submitted.
