**Zoning and Subdivision Committee Report- committee chairman**

1. Iron Mills LDP- Lackawannock Township- Existing commercial development located off of Greenfield Road. **Zoning and Subdivision Committee Report- Larry McAdams, Committee Chairman.**

- Grove City Borough Draft Zoning Amendment Change – The Committee reviewed the Draft Subdivision Zoning Text change to add Public and Private elementary and secondary Schools recognized by the Commonwealth to the proposed Grove City Borough Zoning Amendment in the Industrial District. After discussion, the Committee determined to consider the Draft text amendment. **A motion was made by Larry McAdams, seconded by Tom Sauer, to take into consideration the Draft text amendment to add the “Public and Private elementary and secondary schools recognized by the commonwealth” to the Industrial District for Grove City Borough. The Chairman called for any discussion, hearing none; a vote was called for, and the motion carried**

**Personnel Finance Committee- Jeff Hoy, Committee Chairman**

- Jeff Hoy made a motion, Patty McAdams seconded, to approve the nominating slate presented at the November meeting, consisting of chairman, Bill Anthony; vice chair, Steve Tingley; secretary, Todd Spears, and treasurer, Nick Hanahan. **The Chairman called for any discussion, hearing none; a vote was called for, and the motion carried.**

**Staff Reports and Discussion-**

- Doniele Russell introduced Jacob Matta to the committee, stating that Jacob will be helping with CDBG as well as Community and Economic Development projects.
- Doniele announced the HOME award for the City of Hermitage is \$750,000. She stated she is working with Greenville and City of Sharon. Suzanne and Jason from the city on the City of Sharon award of \$400,000 as well as Greenville’s award of \$400,000. The Mercer County and Lawrence County Regional Grant was awarded, with Lawrence County being the primary applicant.
- Doniele reminded the Committee that the next Department of Conservation and Natural Resources Grant round will open in January. She stated Brian Foster, who is starting in January, has experience with DCNR grants and will be available to assist the communities. These applications take two to three months because engineering drawings and resolutions are required.
- There will be another round of the Home Grant this spring. Small Communities like the town of Greenville are eligible for up to \$500,000. Cities, as well as the County, can

apply for \$750,000. So, if your community has numerous needs for home repairs, please let us know.

- Land Development and subdivision plans are due no later than January 6, 2025, to make the January 20<sup>th</sup> meeting.
- Reminder that the Finance & Personnel Committee Meeting has been moved to 6:00 p.m., the same evening as the Zoning and Sub Committee Meeting. The Full Commission Committee will meet on January 27, 2026.
- Doniele thanked Tara and Liz for taking on the extra workload and stepping up when it was needed.
- Commission Ann Coleman thanked the municipalities for participating in the America 250 Pennsylvania Quilt. The quilts are hanging in the Mercer County Courthouse, and it's quite beautiful. She stated the America 250 Pennsylvania team is going to be touring the state in January. The official kickoff for Mercer County will be at 10:30 am January 26, 2026, in the courthouse rotunda. There will be a slideshow going over the things done here in the county with the ag tour and the civic summit with the middle schoolers.
- Commissioner Coleman also stated that Mercer County is getting a Liberty Bell. Grove City College is donating \$10,000 to pay for the bell because it's their 150<sup>th</sup> Anniversary.
- There will be a large parade on July 4, 2026, and that information will be sent to the communities.
