**Committee Discussion:**

Discussion of committee composition, whether to recommend nine (9) members or seven (7) members to the Full Commission at its meeting on **January 27, 2026**. After discussion, the committee agreed to maintain seven members.

**2. Reorganization of Committee- open the floor for nominations**

**a. Election of Chair-reports to the full commission**

A motion was made by Steve Tingley and seconded by Jay Russell to approve **Rich McCullough** as Chair of the Zoning and Subdivision Committee. The Chair called for discussion; hearing none, a vote was taken, and the motion carried.

**b. Election of Vice Chair-serves in the Chair's absence**

A motion was made by Steve Tingley and seconded by Nick Hanahan to approve **Elliot Lengel** as Vice Chair of the Zoning and Subdivision Committee. The Chair called for discussion; hearing none, a vote was taken, and the motion carried.

**c. Consideration of Secretary (optional) if the committee wishes to have minutes signed, a secretary may be appointed. This position is not required by the bylaws and is a decision of the Committee.** A motion was made by Nick Hanahan and seconded by Steve Tingley to approve **Larry McAdams** as Secretary of the Zoning and Subdivision Committee. The Chair called for discussion; hearing none, a vote was taken, and the motion carried.

**3. Approval of Minutes**

**a. December 9, 2025**

A motion to approve the December 9, 2025, minutes was made by Elliot Lengel and seconded by Matt Stefanak. The Chairman called for any discussion; hearing none, a vote was called for, and the motion carried.

#### **4. New Business**

##### **a. Iron Mills LDP-**

- i. Proposed "Main Street" with six proposed buildings and a private sanitary sewer system to service the entire facility. The applicant is in the process of obtaining approval from the Department of Environmental Protection (DEP) for the wastewater treatment plant. They have received the E&S permit from Mercer County Conservation and both stormwater and post-stormwater approvals from Lackawannock. It was noted that a request has been made to the New Wilmington Volunteer Fire Department, through Chief Echols, for a safety letter due to the absence of public water. A motion was made by Steve Tingley, seconded by Nick Hanahan, to recommend conditional approval of the plan pending DEP approval of the sanitary system. The Chairman called for any discussion; hearing none, a vote was called for, and the motion carried.

##### **b. Zoning Ordinance Update Request-**

###### **ii. Coolspring Township- Energy Regulation Updates**

Liz reported to the group that a request from Coolspring Township was received asking us to help write their zoning amendment request, which we wanted to bring to the board. The letter is proposing that the amendment is for energy generation facilities only in the industrial zoning district as a conditional use only. The will be taking it out of Agriculture, R1 and R2. The amendment would also update Section 600 All Dwelling which would remove minimum floor area and remove the definition of dwelling units in the definition

After substantial discussion, the Board stated that MCRPC can only assist with the writing of the requested zoning amendment. The requests stated in the letter were noted as being highly restrictive and could potentially lead to litigation.

It was stated that the Coolspring Supervisors would be responsible for voting on any proposed changes. In the event of a conflict of interest, the affected Supervisor would be required to recuse themselves, leaving two Supervisors to vote on the matter.

Steve Tingley made a motion, seconded by Elliot Lengel, to decline writing the requested amendment and recommend staff assistance to the member community in helping them draft an amendment, consistent with standard practice. MCRPC would only provide zoning ordinance assistance to Coolspring Township.

The Chairman called for a vote, and the motion carried.


