BLASTING SCHEDULE

Glenn O. Hawbaker, Inc. 1953 Waddle Road, Suite 203, State College, Pennsylvania 16803, proposes to conduct overburden and production blasting in compliance with all state and federal laws (as written within the "Noncoal Surface Mining Conservation and Reclamation Act") at its surface mining operations located in Barkeyville Borough, Venango County: Surface Mining Permit No.: 61190301, Auvil Mine on the lands of Clarence C. III and Cynthia M. Whitfield and Glenn O. Hawbaker, Inc. Blasting may be conducted between the hours of: Sunrise to sunset Monday through Saturday from July 21, 2026 through July 21, 2027.

Warning signs will be placed at every entrance to the operation, and at least one (1) minute but not more than two (2) minutes prior to detonation a warning signal of three (3) blasts, each lasting approximately five (5) seconds, will be sounded. One prolonged ten (10) second signal will be blown as an all-clear signal. Access road barricades will be erected prior to each detonation. Rain, lightening, or other atmospheric conditions, or operator, or public safety, are considered emergency situations and may require unscheduled detonation. If this occurs, identical warning and precaution measures will be taken.

No mining or blasting activities will take place within the permit area in Mercer County until approval has been obtained with regards to conditional use and zoning.

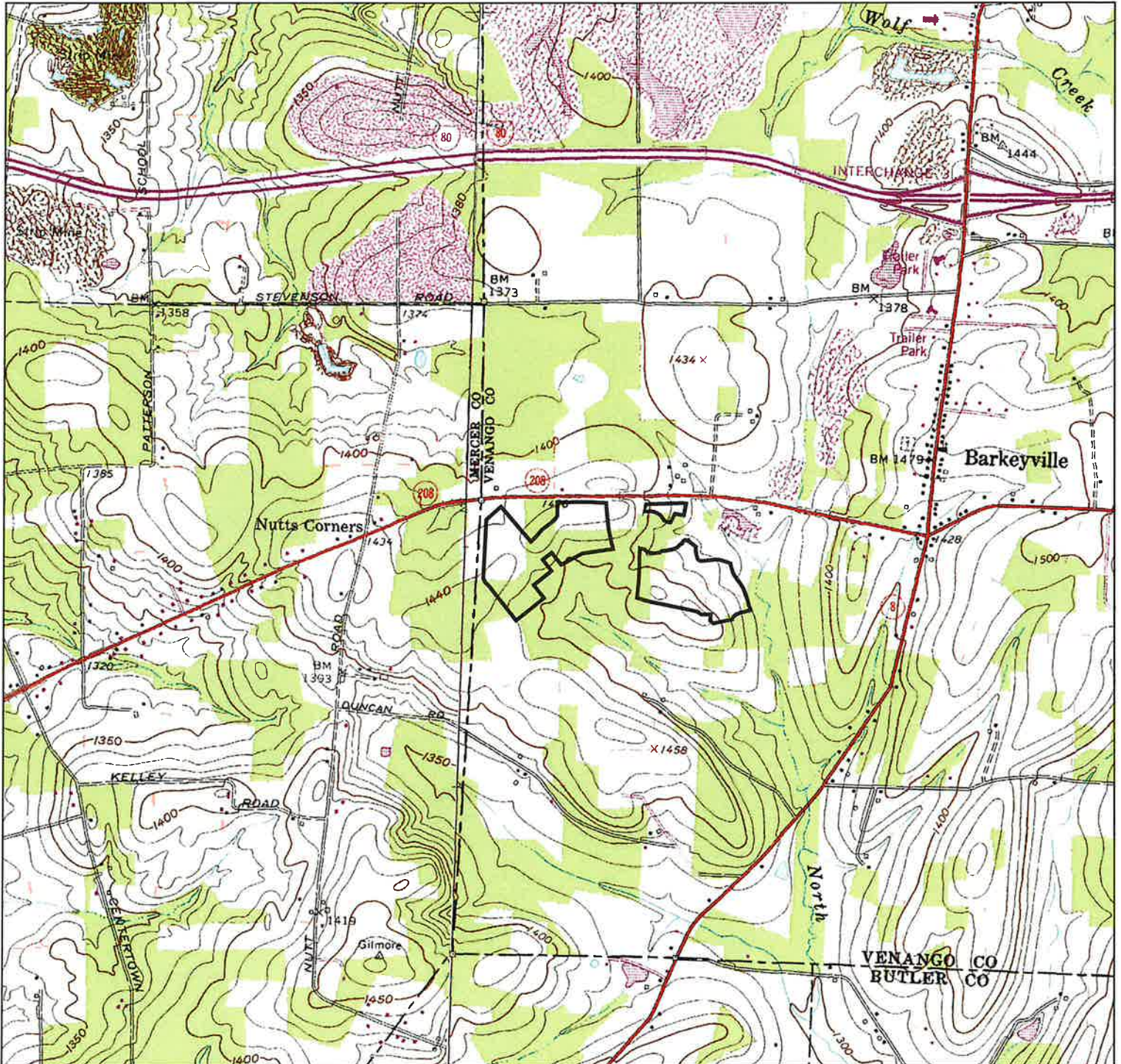
